Making Tax Digital (MTD) is a new initiative from HM Revenue & Customs (HMRC), intended to make it easier for individuals and businesses to keep on top of their taxes and submit information. It is part of HMRC's plan to become more digitally advanced. The overall aim is to make our UK tax system more efficient for all involved, and to make tax easier to manage for businesses of all sizes. The first businesses to be affected, from April 2019, will be those who are registered for VAT (or who will need to register in the upcoming tax year).
